Sign up: The sign up process is your gateway to end-of-year exams. We have to ensure that you have had enough education, training and clinical experience before we accept that you are ready to sit these exams.

Sign up parameters:

- 1. Attendance.
- 2. Professionalism cards.
- 3. iDentity activity.
- 4. Clinical targets and milestones.
- 5. Clinical skills gateways (KPT).
- 6. Coursework.
- 7. Formative assessments.

Sign up will be held at the end of clinical sessions. During this, sign up parameters will be reviewed and evaluated. Also, the student development monitoring can be held at certain time points during the academic year by the year leads to collect comprehensive amount of data and look at them from a variety of angles.

1. Attendance:

Students should have 75% record of attendance. Multiple absences result in the students not being able to have enough experience during the course and therefore unfit to sit final exams.

2. Professionalism cards:

Students are expected to behave in a professional manner at all time during their studies on the program. This not only includes the time spent at the academic or clinical environment but also outside the premises of the faculty. All the students with red cards will be discussed at the Sign Up and based on the pattern and severity of such cards, candidates may be in danger during *sign up*.



3. iDentity activity:

iDentity is a mechanism of recording clinical activity and student-led reflection as well as identifying the development needed for students. You are assessed for subject knowledge, professionalism, treatment quality and patient feedback.

Sv	Satisfactory – Verbal intervention	-Satisfactory clinical outcome was achieved after verbal prompts from the tutorStudent requires occasional prompting to recall knowledge or understand the connection between different pieces of knowledgeThe student acted professionally after verbal prompts from members of staff.
Ι	Independent	-The student is capable of starting and finishing clinical tasks independently. The role of the tutor is purely supportive. No intervention from the tutor was neededThe student has very good clinical knowledge and understandingThe student acts like a professional/graduate dentistThe student's clinical work, understanding and professionalism is comparable with a dentist on 'day one' of foundation trainingThe student received very positive feedback from their patient.
I+	Excellent independence	-The student's clinical work is beyond that expected in their foundation training year. -The student has excellent knowledge and understanding. The student is able to argue their actions based on the available evidence. -The student's professionalism is exceptional; the student is not only able to manage a situation independently but can also lead a team to achieve optimal results. -Exceptionally good feedback from the patient.



4. Clinical targets and milestones:

Clinical targets and milestones ensure that the student is receiving appropriate level of exposure to a variety of clinical procedures. Students failing to demonstrate clinical activity in line with expected clinical targets and milestones are in danger of not being *signed up*.

5. Clinical skills gateways (KPT):

There will be sets of clinical competency which must be passed at the end of year 4. These are classroom tests of clinical skills as well as clinical procedures performed against clear criteria. The students perform a set task while being observed by a staff member. Students failing to achieve a pass marks in these exams are in danger of not being *signed up*.

The course consists of:

- 1. 100% attendance of clinical attachment.
- 2. Completion of a case presentation related to one patient from the Medicine and Surgery performed on proposed date.
- → This will be your gateway to medicine and surgery OSCE.



6. Coursework: Coursework comprises of:

1) Critically Appraised Topic (CAT): This course will enable you to develop the skills needed to appraise oral health research, and to use it in an integrated evidence-based approach.

- Aims:

- To develop an understanding of the importance of research and research methods, and how research evidence relates to clinical decision-making (that will be practiced through EBL sessions).
- o To develop key skills associated with evidence-based practice.
- 2) Case presentation related to one patient from the medicine and surgery performed on proposed date.
 - CAT will be practiced through EBL sessions. The total marks of the course work will involve 50 marks for EBL sessions evaluation. So that, EBL sessions attendance and participation is mandatory.
 - You must exceed 60% of the total marks for course work to be qualified for the final exam. If you did not achieve this percentage, you will be given only one chance for retake and if you did not achieve 60% of course work retake marks, you will be forbidden from the final exam.

7. Formative assessments:

This group of assessments are aimed to give you constructive feedback on your progress. Such assessments are referred to as "assessments for learning". These are SAP and MCQ assessments that will be held from 1/12 to 10/12/2024.

You must exceed 50% of the total marks of each formative exam to be qualified for the final exam. If you did not achieve this percentage, you will be given only one chance for retake and if you did not achieve 50% of each formative exams retake, you will be forbidden from the final exam.

CLINICAL SESSIONS NOTES:

- 1) Periodontics and Pediatric Dentistry practical sessions will be held in the first term only.
- 2) Orthodontic practical sessions will be held in the second term only.
- 3) For endodontics practical sessions:
- First term \rightarrow preclinically (in Manchester sim. lab) using extracted natural teeth.
- Second term \rightarrow clinically (in Manchester clinic) on patients.
- 4) During Ramadan only, the Removable Prosthodontics practical sessions that will be held on Sunday for group 2 and on Wednesday for group 1 will be cancelled. So that, each group will have only one Removable Prosthodontics session per week.
